Terms of Use

Welcome, and thank you for your interest in VTVK, Inc. ("VTVK," "we," "our," or "us") and our website at getrhythms.ai, including subdomains of that website (collectively, the "Site"). These Terms of Use are a legally binding contract between you and VTVK regarding your use of the Site.
